

**PETITION TO RECALL JUDGE PETER MCBRIEN**

**TO THE HONORABLE Jill LaVine, Registrar of Voters, Sacramento County, California:** Pursuant to the California Constitution and California election laws, we the undersigned registered and qualified electors of the County of Sacramento California, respectfully state that we seek the recall and removal of Peter McBrien holding the office of Superior Court Judge in Sacramento, California. We demand an election of a successor to that office. The following Notice of Intention to Circulate Recall Petition was served on February 7, 2008 to Superior Court Judge Peter McBrien.

**NOTICE OF INTENTION TO CIRCULATE RECALL PETITION**

TO The Honorable Peter McBrien, Judge of the Superior Court of Sacramento, Family Relations Courthouse.

Pursuant to provisions of the California Elections Code, the undersigned, registered qualified voters of the County of Sacramento, State of California, hereby give notice that we are the proponents of a recall petition and that we intend to seek your recall and removal from the office of Judge of the Superior Court of Sacramento, Family Relations Courthouse, in the County of Sacramento, State of California, and to demand an election of a successor for that office.

The grounds for the proposed recall are as follows:

You are a disgrace to the American judiciary system and an extreme danger to children and parents. You destroyed a young boy by awarding the father custody after multiple investigations substantiated he had sexually abused the boy FL890348. You awarded custody to an abusive mother, ignoring medical evidence that she seriously physically abused her young daughter 98FL044770. You destroyed trees on public property to improve the view from your home. Charged with a felony, you pleaded guilty to a misdemeanor. After receiving a public reprimand from the Commission on Judicial Performance, you were promoted to the powerful position of presiding judge. You have now embarrassed your profession by abandoning a trial in mid-session 04FL02489. You issued a judgment destroying the respondent's real estate holdings and financial stability. Respondent filed an appeal. You obtained, in secrecy, a copy of the court transcripts, altered them and had the respondent's career destroyed. You have broken at least two California Code of Judicial Ethics canons: A Judge Shall Avoid Impropriety and the Appearance of Impropriety in All of the Judge's Activities and a Judge Shall Perform the Duties of Judicial Office Impartially and Diligently. When will your evil terrorism be stopped?
